**- Minutes -**

On invitation of the Commissioners for Data Protection and Freedom of Information of the States of Berlin and Brandenburg, Professor Dr. Hansjürgen Garstka and Dr. Alexander Dix information commissioners from all over the world met for the first time on 7 April 2003 in Berlin, Germany. They represented 16 institutions from 11 nations (see list of participants in the attachment).

Under the chair of Professor Garstka the commissioners shared their experiences in the implementation and exercise of freedom of information regulations. Each institution as well as their corresponding legal framework were presented. The presentations illustrated the different approaches due to historical and political circumstances as well as legal traditions in the participating countries.

The participants agreed to form a continuous cooperation. For this purpose, a *Declaration of Cooperation* was signed in the afternoon session. The wording of this declaration is as follows.

“Participation in the knowledge of public entities is a legal right of the information society. Without discrimination, any person must be allowed access to the documents of public agencies. A transparent public administration, open to citizen participation in its decisions, is a prerequisite of a modern democratic society.

The Information Commissioners and Ombudsmen who secure freedom of information in their home countries are obligated to preserve and respect these basic principles.
